The Situation

The fallout from the recent bribery cases involving listed Singapore companies have put a dent on the Singapore Inc Brand.

The Solution

To restore public confidence and enhance Corporate Governance, companies can look towards the recently released Anti-Bribery Management System (ABMS) Standard ISO 37001:2016 for guidance.

The standard provides a blueprint for a management system designed to help an organisation to prevent, detect and respond to bribery. It includes a series of measures and controls that represent global anti-bribery good practice. The standard is flexible and can be adapted to a wide range of organisations.

As part of ABMS implementation, large corporations will require their vendors and 3rd party suppliers to have the appropriate anti-bribery controls in place. In this regards, Enterprise Singapore will be providing funding support to SMEs to help to defray the cost for ISO 37001:2016 consultancy and certification.

Nonetheless, there might be some organisations that could face challenges on how to implement an enterprise approach to Anti-Bribery.
